REGIONAL HOUSING PROGRAMME IN FOUR WESTERN BALKAN COUNTRIES (BIH, CRO, MNE, SER) - RHP, 2012-2017, EU, 12.5 M€

The overall objective of the project is to assist the four Partner Countries in finalising the preparation of the specific Country Housing Projects within the joint Regional Housing Programme, and in their subsequent implementation so as to provide sustainable housing solutions in line with international best practices and to the benefit of those most in need. The Regional Housing Programme targets close to 74,000 people or 27,000 households and foresees three eligible housing solutions: provision of flats and houses through building, reconstruction, renovation or purchase; provision of construction materials; accommodation in social welfare institutions.
